

## Registration

1. Sheep may be eligible for registry that are imported from or can trace in all their lines to the flock of I.K. or Peter Downie of Tasmania, Australia.
2. Sheep may be eligible whose sire and dam are registered with ACSA.
3. The breeder of the animal is the party owning the dam at the time of service.
4. The first owner is the party owning the lamb at the time of birth and is responsible for registration.
5. Approved animals will be assigned registration numbers. Ear tags and registry certificates bearing that number will be supplied to the owner. All registered sheep and those eligible for registration must be positively identified at all times, the method of identification (ear tags and ear notch or tattoo, etc.) being left to the discretion of the individual breeder. The association will not acknowledge re-tags different from the original flock number.
6. All applications for registry are subject to denial, and all registrations are subject to termination.
7. Animals with horns must be listed under "notes".
8. A *Certificate of Breeding Service Application* is completed at the time of service and submitted with the *Registry Application and Agreement* for the following conditions:
  - a. When the breeder is not the owner of the ram (the ram is borrowed or leased).
  - b. When ewes are artificially inseminated.
  - c. When ewes are sold as bred or exposed. (See below, item 3. under *Transfers*).

## Transfers

1. The seller completes the transfer information on the back of the *Certificate of Registration* and submits it to the Secretary at the time of sale with the correct fee.
2. Sheep may also be transferred to a new owner at the time of first registration by submitting the new owner's name and contact information under "notes" and including the transfer fees.
3. If a ewe is sold as bred or exposed, the buyer must be given a *Certificate of Service Application* so the offspring can be registered.
